Acting Secretary Cochran and Associate Director for Health Spiro,

We write to you today in support of the Center for Medicare and Medicaid Services rule issued on November 20, 2020: Organ Procurement Organization (OPO) Conditions for Coverage Final Rule: Revisions to Outcome Measures for OPOs CMS-3380-F. We understand that you must conduct a thorough review of many midnight regulations issued by the Trump Administration. As longtime advocates for these reforms, we warn you that any delay in this rule's implementation will cost patients' their lives. While the rule's implementation is now delayed until March 30 to give agency officials "the opportunity for further review of the issues of fact, law, and policy raised by this rule," we request that it be implemented rapidly after this review period. We strongly believe that this critically important and well-designed rule should be enforced as urgently and strongly as possible given the lives and equity implications at stake.

OPOs were established under the National Organ Transplant Act in 1984. This legislation also created the national Organ Procurement and Transplantation Network (OPTN), which is responsible for managing oversight of OPOs. The United Network for Organ Sharing "serves as the OPTN under contract with the Health Resources and Services Administration." There are currently 57 OPOs, each "operating as an unchecked regional monopoly," and performance levels across OPOs are highly variable. According to research conducted by HHS itself, OPOs are failing to recover or transplant thousands of organs each year. This results from various problems, ranging from financial impropriety to quality control issues—including leaving transplantable organs on commercial flights to failure to hire enough staff to respond to all donation cases. In conducting research for the rule proposed in November, HHS even found that OPOs may be choosing not to pursue

procurement of organs from single-organ donors because they are evaluated on the number of organs procured per donor. This central concern of OPO mismanagement, lack of accountability, and metrics-gaming to what the previous Administration successfully worked to address in the final rule issued in November. This rule, building on work begun under the Obama-Biden Administration, is projected to save more than 7,000 lives every year, disproportionately lives of patients of color. It will also reduce costs to taxpayers, decreasing dialysis costs to Medicare by well over \$1 billion annually. We were proud to fight for this rule and we are committed to its future.

The continuity of this rule aligns strongly with the Biden Administration's commitment to creating health equity. ¹⁵ OPOs have been shown to engage in racial profiling and to otherwise provide wildly different service to Black patients and other patients of color, including failing to respond to cases involving Black patients, and treating Black families with less care and compassion as white families. ¹⁶ This has resulted in a deeply inequitable system in which patients of color are far more likely to need organ transplants, and yet are far less likely to receive them. ¹⁷ As Ben Jealous, past President of the NAACP wrote regarding this rule: "Astoundingly, many OPOs are calling for further delay of the new regulations, which would consign thousands of patients—mostly patients of color—to unnecessary death. If we understand the problem and know the solution, to withhold its implementation is cruel and senseless." ¹⁸

Further, because COVID-19 ravages organs and is highly likely to increase the need for organ transplants, these reforms are more urgent than ever. As nephrologists have noted, "The next epidemic will be chronic kidney disease in the U.S. among those who recovered from the coronavirus. Since the start of the coronavirus pandemic we have seen the highest rate of kidney failure in our lifetimes. It's a long-term health burden for patients, the medical community -- and the

U.S. economy." We must move urgently to implement OPO reforms today to serve COVID-19 survivors tomorrow.

Urgent implementation of this rule has been called for by every major patient group engaged on this issue, bipartisan leaders in the House²⁰ and the Senate²¹, all five former Chief Technology Officers at the Department of Health and Human Services (including all three who served under President Obama)²², leading data scientists²³, and national philanthropies²⁴, as well as the editorial boards of the Washington Post²⁵ and the New York Times²⁶, which noted that "an astounding lack of accountability and oversight in the nation's creaking, monopolistic organ transplant system is allowing hundreds of thousands of potential organ donations to fall through the cracks."²⁷

OPOs are currently under separate Congressional investigations from the House Committee on Oversight and Reform²⁸ and the Senate Finance Committee²⁹ into severe mismanagement, fatal lapses in patient safety³⁰, conflicts of interest³¹, and bad-faith, anti-patient lobbying³², including potentially accepting tens of millions of dollars in COVID-19 small business loans despite massive cash reserves. We understand, despite Congressional investigations and scrutiny, that OPOs and their trade association, the Association of OPOs (AOPO), are continuing to lobby to undermine these propatient, bipartisan reforms. Having engaged with this industry for the past two years, we feel a duty of care to relay that for too long contractors have skirted basic accountability in patients' interests.

We urge you to move forward not only with enforcing the newly finalized metrics, but with additional reforms to OPO oversight, transparency, accountability, and finances given the equity implications of both COVID-19 and the broken status quo in those communities who are often not served in the current organ donation system. Given this, we applaud HHS's decision, announced on January 15, 2021, to transfer the Division of Transplantation out of the Health Resources and Services Administration (HRSA) and into the Office of the Assistant Secretary for Health (OASH), in line with calls from patient advocates and racial equity leaders to centralize OPO oversight into an Office of Organ Policy. 33,34
